



## CORPORATE SOCIAL RESPONSIBILITY POLICY STATEMENT

Our policies ensure that we rigorously adhere to the highest standards in ethical behavior, environmental sustainability, engagement and more.

**ABC’s corporate social responsibility commitments are built around four critical areas:**

Our efforts are focused on providing career opportunities, training, and continuing education to the workforce, and leading by example in areas such as workplace safety, health and wellness, diversity and inclusion, and training and development.   - Accommodations Policy – It is the policy of ABC to comply with all applicable laws concerning the employment of persons with disabilities.
